NARRATIVE

This survey was done at the request of Robert Mills in order to locate his property lines. Mr. Mills South line was established by Survey 15–82 and the West line was located by Survey 52–82. See those surveys for a discussion on the establishment of these lines. Existing monuments mark the North—South center of section line of Section 17, this line and the Mills East line are in common. The tract to the North and adjacent to the Mills property, and the Mills ownership were originally one tract. I come deed calls along the section line to establish the point of beginning for both tracts. For the North tract I run North 89°22'32"West to the found monument on the West line, thence South 0°09'46" East along said West line as per deed call a measure of 223.00 feet to a point on the said West line. This establishes the Northwest corner of the Mills tract. From this point I intersect the point of beginning on the section line for the Mills tract to establish the dividing line between the two properties. Mr. Mills deed calls beginning at a point on the center of section line and thence West 245 feet (See survey number 52-82 for a discussion as to the excessive width). The Mills deed then calls South 247 feet TO THE NURPHY TRACT. This makes the distance a more or less call. I therefore place the Southwest corner of the Mills tract at the point where the West line as established by survey number 52-82 intersects the Murphy ownership as established by survey number 15-82. This makes the line short of the deed call as shown. I find no other unusual conditions with this survey.
