NARRATIVE

This partition was done at the request of Mike Lund and Dan Beckner. The purpose of this survey is to determine the exterior of their ownerships in preparation for partitioning of their lands. This required the placement of the Northeast quarter of the Southwest quarter of Section 20. I use the found monuments as shown and establish the West quarter corner of Section 20 at the intersection of the centerline of Dry Creek County Road and an existing North-South fence. I then place the section corner common to Sections 17, 18, 19 and 20 at proportionate distance between the auarter corners North and South, and accept the existing fence as the best available evidence of the East-West position of this corner. This also falls on the direct line between said quarter corners. I place the position of the corner common to Sections 16, 17, 20 and 21 at record distances from the railroad as called for by the Old Book of surveys, page 267 and shown on the railroad map for this area. I place the quarter corner common to sections 17 and 20 at the centerline of Brooks County Road for the East-West position, and at the record distance South of the Center of Section 17 as called by the plat of W.A. Laidlaw Apple Orchard. This is also harmonicus with the record call to the West right of way line of the railroad by the plat of Wilson Orchards. I place the Northerly line of the tracts by offsetting the East-West centerline of Section 20 the record distance of Deed Volume 103, Page 727 (105 rods). This position is very harmonious with the existing lines of occupation as shown. I use the centerline of Newport Avenue at the North line of Westenskow's Subdivision to place the line between the two ownerships, with the South line of the tracts being the North line of Westenskow's Subdivision. I place the right of way of Brooks Road 30 feet West and parallel with the North-South centerline of Section 20, and place the right of way of Crescent Road 30 feet East and parallel with the centerline of said road as monumented by survey number 32-70, which is the basis for the establishment of the right of way. I find the existing fences along the tracts to be harmonious with the deed lines as shown. I find no unusual conditions on this partition.


