NARRATIVE


This survey was done at the request of Ron Matthews, owner of the tract surveyed. The purpose of this survey was to monument the corners of the Matthews tract. There was a question as to the placement of the West line of the tract, and an existing driveway encroaching across the Southwest corner of the tract. I place the lots and blocks of "The Town of the Cove" by the position established by survey number 11-84. All of the surveys and partitions listed in the reference material also used the 1984 survey as the basis for placement. As discussed on those surveys, there is a shift from the lines of occupation, which is at its maximum in this area. The owners to the North, West and South of this tract are aware of this shift. Because of this, the Matthews house actually encroaches into the street right of way as shown. The gravel driveway into the tract of land to the West also encroaches across the Southwest corner of the Matthews tract. I have also prepared a separate map of just the two tracts showing the existing improvements and locations, at the direction of Mr.. Matthews. I also show the 2 ft. gap in title on the tract South of the Matthews tract, as discovered by survey number 042-2002. As discussed on previous surveys, the 15 ft. utility easements across this tract are written with specific courses which do not match the physical location of the utilities. The descriptions end with the statement "or as constructed on the ground". I place the utility easements of deed microfilm numbers 104277 and 104279 along the physical centerline of the overhead utility lines. The existing fence line along the North line of the Matthews tract is on at the Northeast corner, and tapers Northwest as the fence runs West. I find no other unusual conditions on this survey.
