

NARRATIVE

This survey was done at the request of Paul Shorb. The purpose of this survey was to monument and set fence posts along the East, South, West and the West half of the North line of this tract. The Shorb ownership was transferred in two tracts, Tract A being in the East half of Section 4 and Tract B being in the West half of Section 4, as labeled on the above map. I find all of the deeds in this area were written as aliquot potions of Section 4. The Shorb tract has an exception of 33 feet along the North line of the East half of the tract, and also has an additional strip 80 feet wide and 1000 feet long (from the aliquot line) along the South line of the Easterly half of the tract. I base the subdivision of Section 4 on survey number 1-90. I establish the West right of way line by driving a line from the monument set in the West right of way line by survey number 73-78, Northerly to a point 30 feet West of the physical centerline of the road. I place the right of way of Monroe Lane by defining a line 30 feet North of the physical centerline of the road. I find the fence running along the Easterly portion of this survey to encroach onto the Shorb tract as shown. I found an unrecorded 3/4" pipe near the Southwest corner of the Shorb tract as shown. I find no other unusual conditions on this survey.
