

NARRATIVE

This survey was done at the request of Rob Beck, Mr. Beck wished to adjust the existing three tax lots within Block 25 to fit the existing use and lines of occupancy. Exteriors of the Block were established in Survey Number 9–90 and subsequent monumentation for the block as well as the easement line was done in Survey Number 005–1992. I accept the found monuments and retrace the block on that basis. The original survey (9–90) of this block placed the north line of the block North and parallel with the Section Line. Circuit Court decision 91–12–34607 then awarded land along the North line of the block tapering from 2.45 feet at the West end of the Block to 4.16 feet at the East end, to the Oregon Department of Transportation. That same court decision also created the six foot wide utility easement. The positions of the adjusted lines were established at the direction of Mr. Beck. The monument placed on the North line dividing the two northerly tracts was placed on the easement line, and not at the true corner position. I find no unusual conditions with this survey.
