

### NARRATIVE

This survey was performed at the request of Kirk Fenley, ranch manager for Jordan Creek Ranch LLC, owner of the land within. Mr. Fenley wanted to mark the Jordan Creek Ranch ownership within Section 17, Township 4 South, Range 37 East. All section corners are found intact and in good position. A diligent search was performed at the North, East and West quarter corners. There has been significant lagging in the area and no evidence was found at the East and North quarter corners. At the West quarter corner, I found the fir stump and the remains of a pine stump stated on Remonumentation record No. 319—87R. The monumentation record did not call finding anything but a pitch seal on the fir stump, and a pine stump with no blaze or scribing in 1974. I found the fir stump and remains of the pine stump, with no original blazing or scribing visible on either. The relativity between the stump and pine remains were out of position from each other by approximately 5 feet from the original record. The corner position using the stump would have created a degree skew North and South out of this corner. It also would not have matched the distance to the creek topo call by approximately 30 feet. The proportionate position is harmonious with the creek call 363 ft. to the South. I therefore do not accept the stump and remains as original corner evidence and proportion this corner as well. The section was then divided as per BLM Manual of Survey Instructions. I find no unusual conditions with this survey.

The North line of Section 17, Township 4 South, Range 37 East of the Willamette Meridian being S 89°13'00" E, as per Survey Number 019-2005


