




# SURVEY NARRATIVE

THIS SURVEY MAP HAS BEEN PREPARED TO DOCUMENT THE RECOVERY OF SEVERAL SURVEY MONUMENTS LOCATED ALONG THE ISLAND CITY-COVE HIGHWAY AND THE COVE-UNION HIGHWAY. THE RECOVERY OF THESE SURVEY MONUMENTS WAS INCIDENTAL TO AN ENGINEERING SURVEY BEING PERFORMED FOR THE CITY OF COVE FOR PURPOSES OF THE DESIGN OF MUNICIPAL WASTEWATER TREATMENT SYSTEM IMPROVEMENTS AND THE DESCRIPTION AND ACQUISITION OF RELATED UTILITY EASEMENTS. SINCE THIS ENGINEERING SURVEY IS NOT ANTICIPATED TO RESULT IN A SURVEY RECORDING, THIS SURVEY MAP HAS BEEN PREPARED TO PROVIDE A PUBLIC RECORD OF THE EXISTENCE AND CONDITION OF THESE SURVEY MONUMENTS.

THE MONUMENTS DESCRIBED HEREON WERE RECOVERED DURING MAY AND JUNE, 2009. ADDITIONAL SURVEY MONUMENTS MAY EXIST IN THESE AREAS WHICH WERE NOT SEARCHED FOR AS PART OF THIS ENGINEERING SURVEY.



# **MONUMENT DESCRIPTIONS**

- (A) FOUND 3/4" DIAMETER SMOOTH IRON ROD, FLUSH IN GROUND, 0.4' SOUTH OF NORTH RIGHT-OF-WAY FENCE OF HIGHWAY 237, AT ENGINEER'S STATION 548+73.1 PT-40' LEFT-SEE REFERENCE I. NOTE: THE CORRESPONDING MONUMENT AT THIS STATION 40' RIGHT WAS SEARCHED FOR AND NOT FOUND.
- B FOUND 3/4" SMOOTH IRON ROD, O.1' ABOVE GROUND, O.3' SOUTH OF NORTH RIGHT-OF-WAY FENCE OF HIGHWAY 237, WITH 4"X4" WOOD POST MKD: "SHRW POT 570+00.0" STANDING ALONGSIDE, AT ENGINEER'S STATION 570+00 POT-40' LEFT-SEE REFERENCE 1.
- FOUND 3/4" SMOOTH IRON ROD, FLUSH IN GROUND IN SOUTH RIGHT-OF-WAY FENCE OF HIGHWAY 237, WITH 4"X4" WOOD POST MKD: "SHRW" LYING ALONGSIDE, AT ENGINEER'S STATION 570+00 POT- 40' RIGHT-SEE REFERENCE I.
- FOUND 3/4" SMOOTH IRON ROD, 0.3' ABOVE GROUND, 0.5' NORTH OF SOUTH RIGHT-OF-WAY FENCE OF HIGHWAY 237, WITH 4"X4" WOOD POST MKD: "SHRW" STANDING ALONGSIDE, AT ENGINEER'S STATION 590+03.2 PI-40' RIGHT-SEE REFERENCE I. NOTE: THE CORRESPONDING MONUMENT AT THIS STATION 40' LEFT WAS SEARCHED FOR AND NOT FOUND.
- (E) FOUND 3/4" SMOOTH IRON ROD, I.3' ABOVE GROUND, IN NORTH RIGHT-OF-WAY FENCE OF HIGHWAY 237, WITH 4"X4" WOOD POST MKD: "POT SHRW" STANDING ALONGSIDE, AT ENGINEER'S STATION 600+00 POT-40' LEFT-SEE REFERENCE I.
- FOUND 3" DIAMETER BRASS CAP IN CONCRETE POST, BURIED 1.0', MKD: "STATE HIGHWAY DEPARTMENT 843+29.71 PI"-SEE REFERENCE 2. MONUMENT IS ALONG THE NORTH SIDE OF AN E-W GRAVEL FIELD ACCESS ROAD AND IS DETECTABLE WITH A MAGNETIC LOCATOR.
- FOUND 3" DIAMETER BRASS CAP IN A 0.6' DIAMETER CONCRETE POST, BURIED 0.4', Mk.D: "STATE HIGHWAY DEPARTMENT 867+26.37 POST"-SEE REFERENCE 2. MONUMENT IS NORTH OF THE HIGHWAY, EAST OF THE CREEK, AND UNDER THE SOUTHEAST SIDE OF THE MOST SOUTHERLY HAWTHORNE TREE. MONUMENT IS DETECTABLE WITH A MAGNETIC LOCATOR.
