## *NARRATIVE*

This survey was done at the request of Norm Paullus, on behalf of the City of La Grande. Mr. Paullus wanted the exterior of the rock pit monumented. The original conveyance, recorded in deed book 154, page 476 and Page 477, calls to the survey pins set by survey done in 1966 and recorded as Survey Number 029–1991. As the original conveyance is based on the survey, I consider the survey paramount to the record deed calls. The only monuments from this survey that I find are the pin set along the West side of the property. Though Survey 029–1991 indicates the section line and the East and West lines are parallel, said survey does not show a retracement of the section line. I therefore run right angles to the West line and run record distance of 493.90 feet from the existing pins to establish the East line of the property. Establishing the East line in this manner is harmonious with the existing fenceline. The Southeast corner falls in an area currently being mined so no monument was set. Mr. Paullus wanted the geodetic coordinates of all corners. Horizontal datum is NAD-83. I find no other unusual conditions with this survey.
