NARRATIVE

This survey was done at the request of J. Glenn Null, representing the Arie Rysdam Estate. The purpose of this survey is to document a boundary line agreement between the two adjoining tracts shown hereon. The title lines specify the dividing line between the properties to be along the South line of the North one acre of the South half of the Northeast quarter of Section 20 East of Good Road (approved by lot line adjustment affidavit recorded on Microfilm Number 20121512). To accurately place the tracts, it would require a proper subdivision of the section. The interested parties did not want to approach the division in that manner, but instead agreed to hold the fence corner near the Northeast corner of the South half of the Northeast quarter and the fence corner near the North line of said South half of the Northeast quarter on the West side of Good Road as being the representation of the North line of the South half of the Northeast quarter for the purposes of placing the line between the tracts. I compute the required distance to move this line to account for the one acre adjustment as per said affidavit and move this line accordingly. The placement of Good Road is by physical ties along the centerline of the constructed roadway. I hold the radius as called for in deed Microfilm Number 49716 to place the curve. I find no unusual conditions with this survey.
