NARRATIVE

This survey was done at the request of Steve McClelland on behalf of Hancock Forest Management, land manager of the lands within. Mr. McClelland wanted the line shown hereon marked with flagging and orange paint on trees adjacent to the line as well as steel fence posts adjacent to roads. I recover the monuments shown hereon and make a diligent search for the North quarter corners of Section 32 and 33 as well as the Section corner common to Sections 28, 29, 32 and 33. I did not find any evidence of original GLO corners. As there appears to be a gross deficiency in the distance between the Northeast corner of Section 33 and the Northwest corner of Section 32. I find the topographic calls to reflect this distance error and consider them too inconsistent to rely on for placement of the lost corners. I break the section as per BLM Manual of Instructions 2009. The names of the properties shown hereon are designations used internally by Hancock Forest Management. I find no unusual conditions with this survey.
