


## **NARRATIVE**

This survey was done at the request of Martin Birnbaum, owner of the land within. Mr. Birnbaum wanted the West line of his ownership marked with monuments and steel fence posts. The Birnbaum tract was created by Partition Plat No. 1991-007, which was an unsurveyed partition that divided the parent tract along Cherrywood Road. The West line of the tract is a line 60 feet Easterly of the West line of the Northeast quarter of the Northwest quarter of Section 9. I use the section break as per Survey Number 73-78 and that used in Survey Number 019-2006. The pins that represent the Northwest and Southwest corners of the Northeast quarter of the Northwest quarter, set by Survey Number 63-79 are out of position as shown hereon. I place the centerline unusual conditions with this survey.


