NARRATIVE

This survey was done at the request of Toby Koehn, owner of one of the parcels within. The purpose of this survey is to monument the adjusted common line between the two parcels as shown hereon. I find the monuments marking the exterior of the parcels as per Minor Partition 20080004T. I place the new line at the direction of the landowner. There was a 30 ft. wide access easement created by MP 2008004T for access over Parcel 1 to Parcel 2. This lot line adjustment effectively renders this easement unnecessary, and I consider this easement vacated. The 20 ft. wide ditch easement along the East side of Parcel 2 is to be extended Northerly to the South right of way line of Haefer Lane. There will be a connecting easement also granted, connecting the 20 ft. easement to the 2 acre parcel. At the time of this survey, the exact location of the easement was not determined, but will be a part of the final deeding of the 2 acre tract. I find no unusual conditions with this survey.
