


This survey was done at the request of Josh Harman on behalf of Chrisman Development, potential buyer of the land within. This survey was done to monument the exteriors of the property in preparation for an ALTA/ACSM survey. I find that the nail used as the intersection of H Avenue and 12th Street is lost. I recover the monuments along the South right of way line of H Ave. and find them to be harmonious with the record bearing of Surveys 038-1997, 30-80 and 80-80. I offset the line 30 feet to the North to establish the centerline of H Ave. The Southwest lead plug reference to H Ave and 12th Street is the only remaining reference. According to internal City of La Grande records, this plug falls South 50°17' West, a distance of 18.73 feet from the true intersection position. I intersect the H Ave. centerline with a point 18.73 feet from the lead plug to establish the intersection position. This is very harmonious with record bearing to the South quarter corner of Section 8. I establish the West right of way line of Sixteenth Street by driving a line from the found pin set by Survey Number 30-80 to a point South 0.26 feet and West 0.57 feet from the iron pipe at the Northeast corner of the block. I find all dimensions to be harmonious with record measurements as per Surveys 30-80, which placed this portion of Homesite Acres. These lots were originally monumented by Survey Number 52-76, however the placement of H Avenue appears to differ slightly from the alignment as placed by Survey Number 30-80. I replace all monuments that have been removed and/or disturbed.

I find no other unusual conditions with this survey.
