NARRATIVE

THE PURPOSE OF THIS SURVEY WAS TO DEFINE THE BOUNDARY OF THE NORTH HALF OF THE NORTHEAST QUARTER AND THE EAST HALF OF THE NORTHWEST QUARTER OF SECTION 34, TOWNSHIP 5 SOUTH, RANGE 38 EAST, WILLAMETTE MERIDIAN, UNION COUNTY, OREGON, AS REQUESTED BY CLINT AND GERALDINE DODGE. MONUMENTS WERE FOUND AND HELD, AS SHOWN HEREON. A MONUMENT WAS SET AT THE WEST QUARTER CORNER FROM ORIGINAL EVIDENCE. MONUMENTS WERE SET AT THE CENTER QUARTER, THE CENTER-WEST SIXTEENTH, THE CENTER-NORTH SIXTEENTH, THE WEST SIXTEENTH ON THE NORTH BOUNDARY AND THE NORTH SIXTEENTH ON THE EAST BOUNDARY OF SAID SECTION TO MARK SAID BOUNDARY, AS SHOWN.

NO UNUSUAL CONDITIONS WERE ENCOUNTERED DURING THE COURSE OF THIS SURVEY.
