NARRATIVE

This survey was done at the request of Keith Powelson. Mr. Powelson wanted to enter into a boundary line agreement with Mr. Grage along their common boundary. I recover the monuments as shown hereon. I establish the position of the East quarter corner of Section 35 by distance intersect from the reference pins. The East end of the boundary agreement line was placed at the true title position and the portion of the common boundary between Powelson and Grage that falls along the East line of the Powelson tract is the true title line. For the North line, the boundary line agreement line is to run due West. The monument at the West end of the boundary line agreement was set at an existing North/South fenceline, though this monument is to hold for the line only and does not represent the true West terminus of the line. The true corner is to be established by extension to the West line of the Southeast quarter.

I find no unusual conditions with this survey.
