

LOT LINE ADJUSTMENT

<u>Rankin – Before Adjustment</u>

All that portion of the Southeast quarter of the Northwest quarter and all that portion of the Southwest quarter of the Northeast quarter of Section 6, Township 3 South, Range 38 East of the Willamette Meridian, Union County, Oregon, lying Easterly of the Old Oregon Trail Highway and Westerly of the old county road; EXCEPT Gangloff Park, AND ALSO EXCEPTING a strip of land 100 feet in width along the Westerly side of the old county road, heretofore deeded to the City of La Grande, Union County, Oregon.

TOGETHER WITH, an easement 40 feet in width running from the old county road (now known as Pioneer Drive) across the Northwesterly end of the 100 foot strip conveyed to the City of La Grande by Book 110, page 12, deed records of Union County, Oregon.

Containing 286,753 sq. ft. (6.58 acres)

A parcel of land situate in the Northwest quarter of the Southeast quarter of Section 6, Township 3 South, Range 38 East of the Willamette Meridian, La Grande, Union County, Oregon:

Beginning at a point on the Easterly line of the State Highway (formerly U.S. Highway 30) which has been found by survey No. 8-82, filed with the Union County Surveyor as being South 470.23 feet and East 199.44 feet (South 22°59'00" East, 510.78 feet) from the Northwest corner of the Southeast quarter of said Section 6,

Thence: North 64°46'20" West, a distance of 393.56 feet, to said East right—of—way line, said point being on a 470.00—foot radius curve to the left,

Thence: Along said curve, also along said East right—of—way line, a distance of 259.93 feet, through a central angle of 31°41'13" (the long chord which bears South 28°19'01" East, a distance of 256.63 feet),

Thence: South 44°09'38" East, continuing along said East right—of—way line, a distance of 119.81 feet, to the PC of a 439.26—foot radius curve to the right,

Thence: Along said curve, also along said East right—of—way line, a distance of 131.30 feet, through a central angle of 17°07'34" (the long chord which bears South 35°35'50" East, a distance of 130.81 feet) to the Point of Beginning.

Situated in the Southeast quarter of the Northwest quarter and the Southwest quarter of the Northeast quarter of Section 6, Township 3 South, Range 38 East of the Willamette Meridian, Union County, Oregon, more particularly described as follows, with reference to Survey Number 010—2020, as filed in the office of the Union County Surveyor,

Beginning at a point on the East right of way line of Old Oregon Trail Highway (Highway 30), said point with bears North 22°18'48" West, a distance of 453.21 feet from the Southwest corner of the Northeast quarter of said Section 6, said point being on a 470.00—foot radius curve to the right,

Thence: Along said curve, also along said East right—of—way line, a distance of 103.22 feet, through a central angle of 12°34'59" (the long chord which bears North 6°10'55" West, a distance of 103.01 feet).

Thence: North 0°06'38" East, along said East right—of—way line, a distance of 85.12 feet, to the PC of a 954.99—foot radius curve to the left,

Thence: Along said curve, also along said East right—of—way line, a distance of 260.62 feet, through a central angle of 15°38'10" (the long chord which bears North 7°42'27" West, a distance of 259.81 feet), to the Southwest corner of that tract known as Gangloff Park, conveyed to the City of La Grande by deed recorded as Microfilm Document Number 107360, deed records of Union County, Oregon,

Thence: North 25°07'45" West, a distance of 321.09 feet, to the North line of the Southeast quarter of the Northwest quarter of said Section 6,

Thence: North 89°33'35" East, along said North line, a distance of 71.99 feet, to the West right of way line of Pioneer Drive,

Thence: North 4°15'38" West, along the West line of said City of La Grande tract, a distance of 250.30 feet.

Thence: North 64°46'20' West, a distance of 393.56 feet, to the East right of way line of Old Oregon Trail Hwy (Highway 30), said point being on a 470.00—foot radius non—tangent curve to the left,

Thence: Along said curve, also along said East right of way line, a distance of 259.93 feet, through a central angle of 31°41'13" (the long chord which bears South 28°19'01" East, a distance of 256.63 feet),

Thence: South $44^{\circ}09'38''$ East, along said East right of way line, a distance of 119.81 feet, to the PC of a 439.26-foot radius curve to the right,



Thence: South $4^{\circ}58'08$ " East, along said East right of way line, a distance of 178.45 feet, to the PC of a 543.11-foot radius curve to the left,

Thence: Along said curve, also along said East right of way line, a distance of 134.78 feet, through a central angle of 14°13'06" (the long chord which bears South 12°04'45" East, a distance of 134.43 feet) to the Point of Beginning.
