NARRATIVE

This survey was done at the request of Karli Tatum, owner of the land within. Ms. Tatum wanted to monument the exteriors of her property. The West line of the property was resolved by the plat of Roger's Subdivision. I find monuments from said subdivision to be harmonious with the plat, with the notable exception of those monuments along the West line of this property. At the Northeast corner of Lot 1, Roger's Subdivision, I find an unrecorded 3/4" iron pipe. Not knowing the origins of this pipe, I reject this monument and set the pin as per Roger's Subdivision. I hold the positions of the monument set by East Haven, along the West right of way of 22nd Ave, as per Partition 20090012T, which noted the disturbed position of this monument as well as the offset from the pin set by Survey 53–81 to the initial point of East Haven. The Tatum tract has the senior right over the parcel to the South and I give her property full measure as per the legal description. I find no other unusual conditions with this survey.


