

NARRATIVE

This survey was done at the request of llene Davis, owner of the land within. Ms. Davis wanted the line between Lots 9 and 10 monumented prior to fencing. I accept monuments at the intersection of Fifth Street and F and E Streets. The aluminum cap at Fifth and F Street has been paved over recently and I use a record position as per Survey 030-2011. E Street was placed as per Survey 016-2017. The monument at the North end of F Street was set by Barry Barbour in Survey 27-78, where he utilizes the power transmission line to place the North line of the town of North Powder. In Survey 52-81, Howard Perry notes the discrepancy between the distances along this North tier of blocks as per Barbour's survey versus the platted distances of the town of North Powder. Though I can find no flaw in Perry's logic, the lines of possession along the North line of the town of North Powder appear to fall in line with the Barbour monuments, and due to the long standing nature of these monuments, I accept them in place. The North end of E Street was placed at record distance in Survey Number 016-2017 and I use the position as established. I find no other unusual conditions with this survey.


