

This survey was done at the request of Jeff Evans, purchaser of the accruing tract of this lot line adjustment. Mr. Evans wanted to adjust the lines such that there were adequate setbacks from the existing garage. The dimensions of the Town of Summerville are based on the 1888 plat, done by C.M. Foster, which also depicted the lots within Shaw's Addition. There was no monumentation at the time, and the first instance of a recorded survey within the Town of Summerville was done by Greg Blackman in Survey 98—79. This involved a study tying existing fencelines, roads and improvements to best fit the original plat to existing conditions. This was later accepted in Surveys 030—1994 and 003—1996 (which placed lines within Blocks 2 and 13. I find monuments from these surveys as shown, and find them relatively harmonious with the record dimensions of Survey 98—79. The exception being that in a survey in Block 8 of Shaw's i fina monuments from these surveys as shown, and fina them relatively narmonious with the record almensions of Survey 96—79. The exception being that in a survey in Block 8 of Shaws Addition done my myself, (Survey 038—2019) I held the center quarter corner position (originally established by Old Book Survey Page 357 and perpetuated in Survey 93—78 by a PK Nail). to establish the East right—of—way line of Main Street. This makes for minor differences in pins along Main Street.

I hold dimensions of block, as per Survey 98—79, with exception of taking the difference out on the West line of the Block due to holding the center quarter corner position. I place the adjusted line at the direction of the Mr. Evans. The fenceline along the East side of the property appears to have been constructed prior to the vacation of the alley and is therefore off of

the true title line as shown.

I find no other unusual conditions with this survey.

LEGAL DESCRIPTION OF ADJUSTED AREA

A portion of vacated Shaw Street, accruing to Lot 1 of Block 6, Town of Summerville by Vacation Ordinance No. 2, Series 1980, recorded August 8, 1980, as Microfilm Document No. 93915, more particularly described as follows, with reference to Survey Number 008—2023, as filed in the office of the Union County Surveyor:

Beginning at the intersection of the centerline of vacated Shaw Street and the South right—of—way line of Third Street,

Thence: South 27°03'53" East, along said centerline, a distance of 43.88 feet,

Thence: South 62°56'07" West, a distance of 15.00 feet,

Thence: North 27°03'53" West, a distance of 43.88 feet, to said South right—of—way line of Third Street,

Thence: North 62°56'07" East, a distance of 15.00 feet, to the Point of Beginning.


