



NARRATIVE

This survey was done at the request of Lyn Welch, owner of the land within Mrs. Welch wanted to monument and post the exterior of her property prior to fencing. In the course of doing this survey, however, it was discovered numerous building encroachments that Ms. Welch and the adjoining property


owners wished to remedy. I recover the monuments that define the section as shown hereon. I find the Section monuments to be harmonious with Survey Number 111-78 and also find relative harmony with the monuments set by Survey 30-83. The legal description to the property and the adjoiner to the South are all described by metes and bounds and confined to the Southwest quarter of the Section 20 I break the section as per BLM Manual of Instructions 2009. The subject property is defined as the North 200 feet of the parent parcel described in Deed Book 117, Page 78. I place the South line by offsetting the North line of the Northeast quarter of the Southwest quarter 200 feet. I place the Northwest corner of the Welch tract by holding record 48 rods from the Center quarter. To place the West line I hold the pin set by Survey 30-83 on the East side of Pumpkin Ridge Road.
I place Pumpkin Ridge Road by holding the centerline of the constructed location. This puts a small triangle of Welch ownership within

the right of way, as shown.

place the adjusted line at the location agreed upon by the neighbors. there is a significant fence encroachment along the East side of the Welch property. The adjoiner to the North did not wish to grant this are East of the fence to the Welch property

Adjusted Tract A remedies several building encroachments on the Welch property from the Mendel property. Adjusted Tract B remedies the lack of frontage along a county road by the Welch property. Adjusted Tract C remedies the encroachment of the building on the Welch property on the Hanson property.

I find no other unusual conditions with this survey.
