Posting of the Forest Service boundary was done by Ronald Stoll in Survey Number 051-1994. I find the brass cap at the NE 1/16th corner and the reference monument at the C-N REGISTERED 1/16th corner. I can find no remains of the corner set at true C-N 1/16th position. Date Received 4/4/24 I tie the constructed highway to place the highway alignment. I find gross discrepancies between the constructed road and Strip Map 5B-7-7. I therefore place the highway right of way by holding the centerline as constructed and offsetting 30 feet. I run the deed record 418 feet West from the OREGON intersection of the West right-of-way line and the aliquot line to place the Northwest corner of the Rayl JEFFREY S. HSU tract. I run the West line of the Rayl tract parallel with the highway right-of-way, as per deed 83571 description. Fences are off as shown. I find no other unusual conditions with this survey.
