



NARRATIVE

This survey was done at the request of Connie Short, owner of the land within. Mrs. Short wanted the portion of her lands within Hindman's Addition as well as those portions of vacated Dogwood to be surveyed. I recover monuments as shown hereon. I place the centerline of Cedar Street by holding the railroad spike at the intersection of Ninth and Cedar Street and holding the intersection of Cedar Street and 11th Street as established by Survey Number 023–2020. To place the railroad right of way, I hold the centerline of the tracks in their constructed location, offsetting 50 feet either side. To place the East line of Hindman's Addition, I extend the West right-of-way line of Ninth Street South. I place the South line of Block 77 as per the plat of Hindman's Addition. I place interior lots by standard proportion, running lot lines parallel with the East line of Block 77.

I hold the pins set by Survey Number 008—1997 as being on the South line of Dogwood Street, post vacation. The location of the terminus of Dogwood is somewhat ambiguous in the ordinance, however, Survey 008—1997 places this at the East line of Block 3 of South Elgin. I do the same on this survey.

East line of Block 3 of South Elgin. I do the same on this survey. The portion of the property lying South of Hindman's Addition was created in the vacation of Dogwood Street, by City Ordinance No 8, Series 1994, recorded in Microfilm Document No. 156255. The creation of Dogwood Street is ambiguous on the plat of South Elgin, the plat noting it as a 30 foot right-of-way, however, the dedication of the plat does indicate that extents of South Elgin were based on aliquot lines. The vacation resolves this ambiguity by vacating any areas outside of a 60 foot right of way. Though the intent of the vacation appears to be to accrue vacated areas North of Dogwood Street to the owners to the North, as per ORS 271.140, original boundary lines are to be adhered to when disposing vacated lands from public ownership. This title ambiguity was resolved along the Short property by quitclaim deeds filed as Microfilm Numbers 971422 and 20034997. Title to land along Lots 1 and 4 are a bit more ambiguous. Deeds for those portions were filed as Microfilm Document 20171353 and 20170821. Legal descriptions of these deeds are ambiguous at best. Though it is past the scope of this survey to resolve the exteriors of those boundaries, it has a clear exception to any portion of land lying within Microfilm Document 971422. I therefore extend the East line of Lot 5 South to the North line of Dogwood Street.

A fenceline for the property to the East encroaches by approximately 7 feet. I find no other unusual conditions with this survey.
