


BASIS OF BEARINGS GEODETIC NORTH

NARRATIVE

THIS SURVEY WAS PERFORMED FOR THE UMATILLA NATIONAL FOREST, WITH THE PURPOSE OF REESTABLISHING THE OBLITERATED CENTER-EAST 1/16 CORNER SECTION 6, T. 1 N., R. 38 E., W.M., WHICH IS A CONTROLLING CORNER ON THE NATIONAL FOREST BOUNDARY.

A SEARCH WAS MADE OF THE AVAILABLE RECORDS PERTAINING TO THIS SURVEY. IN 1980, GARY LANGLITZ, PLS #1099, SUBDIVIDED SECTION 6 DURING A SURVEY FOR THE U.S. FOREST SERVICE, UNDER CADASTRAL CONTRACT NO. 53-04R3-0-01125. SAID SURVEY WAS RECORDED AS SURVEY NO. 97-80 IN THE UNION COUNTY SURVEYOR'S RECORDS. A CORNER MONUMENTATION RECORD FOR THE CENTER-EAST 1/16 CORNER WAS FILED AS 21-84R.

DURING THE COURSE OF BOUNDARY MAINTENANCE ACTIVITIES BY FOREST SERVICE PERSONNEL, THE MONUMENT AT THE CENTER-EAST 1/16 CORNER WAS SEARCHED FOR BUT NOT FOUND. THE CORNER POSITION FALLS ON THE WESTERLY EDGE OF DRY CREEK, WHERE THE MONUMENT HAS APPARENTLY SUCCUMBED TO THE MIGRATION OF THE CREEK CHANNEL. BOTH BEARING TREES ESTABLISHED BY LANGLITZ WERE FOUND ALIVE AND IN GOOD CONDITION. ALL OTHER MONUMENTS FOUND DURING THE COURSE OF THIS SURVEY WERE ACCEPTED, AS SHOWN

I DECLARE THE CENTER-EAST 1/16 CORNER OBLITERATED, AND REESTABLISHED IT BY DISTANCE-DISTANCE INTERSECTION FROM THE TWO FOUND BEARING TREES. TWO REFERENCE MONUMENTS WERE ESTABLISHED ALONG ALIQUOT LINES AT SAFE DISTANCES FROM THE EDGE OF THE CREEK TO HELP PERPETUATE THE CORNER, AS SHOWN HEREON.

SEE THE CORNER MONUMENTATION RECORD FILED SEPARATELY FOR MORE DETAILS REGARDING THIS CORNER AND ITS ACCESSORIES.


