Section 2: Description of Services

Provide meals for golfers, volunteers, parents and spectators for the event period of Monday, June 28 through Friday, June 2, 2021. Provider must be 100% self-contained as Buffalo Peak has not kitchen facility available.

A food and payment guarantee will be provided for golfers for Monday, Tuesday and Wednesday at a number estimated at 150 per day, to be finalized by June 1.

Food should include a main item, bottled water, and additional item(s) (example, sandwich, bottle of water, chips and/or veggies, cookies, fruit). Offerings should also include a few glutenfree options along with Vegan and Vegetarian options. Daily choices could include (examples only):

- Ham & Cheese Sandwich
- Turkey & Cheese Sandwich
- Hot Dog
- Hamburgers/Cheeseburgers
- Pulled Pork

In addition to providing food for the guaranteed number, provider should be prepared with food to sell to volunteers, parents and spectators. These food sale opportunities will extend through Friday.
