

## MEETING MINUTES LPSCC/LCJAC

AUGUST 27, 2024

1. Meeting Minutes 02/05/24–Moved by Dave Adyelotte, seconded by Matt Scarfo. Minutes approved.
2. 96 Hour arraignments – starting daily 10/1 at 1:15. K. McDaniel noted that she will be meeting soon with Cody Bowen, Gary Bell, and Dave Adyelotte soon to iron out details for what that is going to look like for timely law enforcement reports, etc.
3. Welcome to new MH Director Barb Seatter and Juvenile Director Odin Miller. Matt Scarfo will do order appointing these new reps. K. McDaniel noted that the Lay citizen representative position is also vacant as Pete Candlish relocated out of the area. Matt Scarfo will add this vacancy to the county website for applications. Once that is filled, he will combine everyone on one order.
4. Table the Pre-trial SIM review until the next meeting
5. Update on Diversion/deferral program – K. McDaniel, Logan Joseph, Valerie Schlicting are working on a soft launch for Sept 3 for PCS charges. Funding is in place. Looking to hire a part-time coordinator to handle.
6. LPSCC and LCJAC Bylaws re: voting via email and proxy stand in language. K. McDaniel moves to adopt. Chief Bell seconds. Approved.
7. Probation questions – Travis Miller noted that yes, local PO's would arrest on warrants, secret indictment or not.

HB 4002 DEM monitoring, Local probation is on board with this process. Travis shared flow chart with the group.

8. Department Updates
  - a. La Grande PD – Chief Bell, Nothing new to report
  - b. DA – Kelsie's updates noted above. DDA Kassadie Curtis expected to return to the office in about 30 days.
  - c. Court –Nothing new to report.
  - d. Defense Bar Jim Schaeffer - noted changes coming with staffing due to Jared Boyd closing his practice soon. Kyra Rohner, Will Thomson will be stepping in to help fill gaps for court appointed attorneys.

- e. Commissioners, Matt Scarfo reported that the county has secured a contract with Pinnacle to do research for a Detox facility.
- f. Juvenile department, Odin Miller – very busy. Excited for the future. Looking to fill 1 staff vacancy.
- g. Probation, Travis Miller – newest PO Miranda has completed field training, so she is up and running, taking on caseload. They are opening position for probation services counselor.
- h. CHD Barb Seatter – OHA has been reaching out to CMHPs for local projects they have in the pipeline – would be helpful to have more information on goals for the Detox facility to share with OHA. CHD is short staffed, but in the process of hiring for several new positions.
