- **Approve Minutes of last meeting May 5, 2025 Motion by Tyler, Second by Norm. All in favor.**

- **Parking program update – Josh Ford, Informational** Program is going well. Have made about 16,500. Sales of annual passes has slowed down and day use passes has picked up.

- **Archeology Report – Josh Ford, Informational** Ian and Josh meet with State Historic Preservation Office (SHPO), Substrate Collaborative Anthropological Research (consultants) and Confederated Tribes of the Umatilla Indian Reservation to look at the logging activity on the Owsley/Igo areas. Need to continue working on burn piles. Looked at 3 Jeep Trails: Mainline, Onion Flat and Cutoff. Discussed options for repair of rocking, building rolling grade dips and installing culverts. Will need to dig test pits at sites of disturbance. Can apply for ATV Fund Grants but need 20 percent match.

Have 52 non-motorized trails. 12 have been adopted by Blue Mt Singletrack Club. 7 by other people.

- Trail ratings- Sean Lerner, Discussion

Discussion on ratings of certain trails and how the other bike areas. Some trails have short difficult section (crux) while the rest of the trail is much easier. But need to rate on hardest section. Some areas use a system with a split grade with most the route being the first color and the crux is the second color. There are 5 rates that we could potentially have a split grade.

- Doing Time - Blue/Black
- Upper Hot Shot - Green/Blue
- Skill/Sloman - Blue/Black
- Slammer - Green/Blue
- Depends - Green/Blue

Hard to change on map right now but could do some on the ground sign changes.
