- 5) Stalking Order referrals Court is seeing a lot of stalking complaints denied for as the parties are not meeting the legal burden. Many of the filers are indicating to the court they were referred by law enforcement and/or the Shelter from the Storm. Judge Powers reminds everyone that there is a higher bar for stalking. For example Texts may not meet that criteria. Court is inquiring.

Are they coming from PD

Chief Bell from the Police Department indicates their general procedure is to have the person coming to them for assistance work with their Special Victim's Advocate. Recognizing that there ae a lot of new folks on the force, Chief Bell will make time to have some refresher training with his team on this process to avoid referrals if occurring without discussion with the customer regarding the high bar of proof necessary for a judge to find good cause and allow the protection.

Are they coming from the shelter

Jamie Swensen from Shelter from the Storm indicates that their representatives generally go over the criteria for restraining orders and stalking complaints with customers who are coming to them for help with the court process. They are also making sure the customer understands their responsibility to meet the high burden necessary for the court to find good cause. Jamie will share with their staff the concerns of the court and make sure they are all following protocol in terms of helping customer understand whether they meet the high burden of proof to obtain the protective order.
