II. PUBLIC HEARINGS

Continuation of Application 2026-0007. Major Partition for Josh and Caitlin Russell. Planning Commission discussion and decision.

Application No. 2026-0021. A request for a Relative Farm Help Dwelling for a relative of the farm operator. The property is described as T02S R38E Tax Lot 400 and T02S 38E Tax Lot 401. Adjacent property owned by the applicants are T02S R39E Section 07 Tax Lot 400 and T02S R39E Section 06 Tax Lot 800. The situs address for the subject property is 64676 Sandridge Road, La Grande. Applicable zoning district is A-1, Exclusive Farm Use. The property owners/applicants are Melanie and Matthew Insko. The applicable land use regulations are UCZPSO Article 2.00 A-1 Exclusive Farm Use Zone; Article 21 Conditional Uses; Oregon Administrative Rules 660-033-0130(5).

Application No. 2026-0025. The City of La Grande has proposed amendments to the City's land development code, which may affect the permissible uses of property within the City's Urban Growth Boundary (UGB). The county and the city have an agreement that the city will implement land use regulations within the UGB, but the county is still required to co-adopt amendments to the city's land use regulations and comprehensive plan. The City of La Grande is proposing amendments to the residential land use codes, found within City Code, Subpart B – Land Development Code. The proposed amendments are intended to bring the City's codes into conformance with housing-related legislation passed by the State of Oregon. The adoption of the proposed ordinance may affect the permissible uses of properties within the UGB, and may

change or influence the value of properties. The Planning Commission is not the decision maker for this application; they will make a recommendation on this application to the Board of Commissioners. The Union County Board of Commissioners will hold a public hearing on this application on July 15, 2026. The meeting starts at 9 AM and takes place at the Joseph Annex Conference Room, 1106 K Avenue, La Grande. You are encouraged to check the Commissioners' meeting agenda for the exact start time of the public hearing.

Application No. 2026-0027. A request for a Home Occupation to operate a small scale auto repair/resale shop out of a home shop. The property is described as T03S R40E Section 22BD Tax Lot 700. The situs address for the subject property is 60331 Leopard Dr., Cove, OR 97824. Applicable zoning district is R-2 Rural Residential. The applicant is Curtis Pedro and the property owners are David and Kristin Colton. The applicable land use regulations are UCZPSO Article 7.00 R-2 Rural Residential Use; Article 21.00 Conditional Uses.
